## ACCESS

**NCMA has diligently increased the value of Subscriptions to organizations, including the following benefits:**

## AFFORDABILITY + PORTABILITY

- The \$25 initiation fee reserved for individual memberships is waived.
- Payments are made in one lump sum, so every seat within the Subscription shares the same expiration date.
- Organizational Subscriptions are owned by the organization, not the individual.
- For Department of Defense (DOD) agencies, the 2020 NDAA established policy to allow DOD employees to participate in professional associations and societies, consistent with the performance plan of each employee.

For each Organizational Subscription, a minimum of 10 "seats" must be purchased—which are purchased in lieu of individual memberships. More seats can be added at prorated rates throughout the subscription year.
